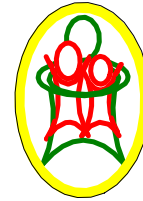

## NEWS FROM THE HOME

Barry Barnes reported that the dedicated childcare continues successfully and is impressive to see in difficult situations. The children attending the community projects supported by the home, who are unable to pay for uniforms and school fees, are cared for by local volunteers. Often these are elderly women, who do their best to give the children a basic education without any resources.

There have been financial problems since last summer, leaving senior staff unpaid for several months and a slowing of progress completing the crèche and other buildings in the community projects. However we heard in February that one classroom has been completed in the crèche and another one should be usable by the time Shelley arrives in April. She believes it will be a great asset when completed.

New water tanks have been installed to ease supply when the water is cut off.

The field donated to the Home by the Methodist Church is being farmed but expertise and improved water supply is desperately needed. When in full use it will give the Home a more independent food supply. Shelley had watched an excellent Nativity play being rehearsed at the Home making the best of few resources. The driving force is Astonishment's vision for improvement. A new Board of Governors has been formed at the Home.



Children at the Home receive extra help in the Home's classroom, given voluntarily by a local teacher.

Rev Margaret Mawire from Zimbabwe, who knows the Home well, is studying for one year at the same college as Shelley and is helping her to learn Shona, the language spoken by the children. She spoke of her concern to improve the education of the children at MRCH.

### **Mission partner**

Shelley told us about the training she is receiving in Birmingham. She is studying contextual theology and caring for traumatised children. Children with special needs can be neglected and part of her role will be to train staff to further improve the quality of care generally. Action for Children is providing the childcare training and the work with children with HIV/AIDS.

Shelley will be building up as many links as possible in the UK, including with the Zimbabwe Methodist Fellowship UK, before she goes to Zimbabwe in April and her prayer card will be distributed as widely as possible. She will be sending regular reports back to the UK and we shall pass her news on to you all.

I recently visited Zimbabwe on my familiarisation tour as the Partnership Coordinator for Africa for the British Methodist Church. I had the privilege of meeting Mr Astonishment Maripusa – the National Director of Matthew Rusike's Children's Home at Epworth, Zimbabwe. Among other things, I was impressed by the self-help farming project to support feeding the children of MRCH and from surrounding communities.

Once upon a time I had to leave Matthew Rusike Children's Home after living in that institution for more than seventeen years. for me this was a turning point as I was now heading into the 'real world'. I had lived in the home since 1988 after my mum's death and my father abandoned me. As a norm, since I was now above eighteen I had to be discharged and pave way for other children in need. By that time I felt so out

and hopeless as I wonder where I was going to get the money to carry on with my education. I just give all the credit to Mr Mapurisa who promised to keep on helping me even when I was no longer staying at Matthew Rusike Children's Home.

I proceeded to Advanced Level and my guardians (UK sponsors) still paying my fees through the Home. I came out well and got a place at the University of Zimbabwe where I acquired a degree in philosophy. By the way I am one of the few girls from the institution who was able to make it to the University Level! I then graduated in March 2010. I am now working at a certain Non Governmental Organisation though still under internship. My life alone is a living testimony because of what the institution brought out of me. Something that I always believe would never have been this good even if my parents were still alive and together. Every time I wake up I always feel I owe Matthew Rusike Children's Home, my UK sponsors, all other sponsors and above all the Almighty, big time, for this life that I enjoy now....if only there was a word stronger than 'thank you'!!!
